I am to say that the All India Trade Test for Craftsmen (Suppl.) is scheduled to be held from **30.01.2012 to 4.02.2012**.

In this context, I am to say that the trainees intend to appear in the above trade test are to fill up form and the fill in forms alongwith the trade wise list should be submitted in the proforma **I** and **II** (copy enclosed) in duplicate to appear the above All India Trade Test to this Council latest by **21.01.2012**.

The failed trainees who have completed six chances within a period of 5(five) years after completion of training period are not eligible to appear the above trade test under any circumstances. Hence a certificate of the principal to this effect that the trainees as per list to appear AITT for Craftsmen(Supplementary) have not exhausted six chances within a period of five years after completion of their training period may please be furnished below the tradewise list of trainees in proforma-I.

3. Filling up forms and collection of trade test Fees with fine @Rs.10/- per trainee. 18.01.2012
4. Filling up forms and collection of trade test Fee with fine @ Rs.50/-per trainee. 19.01.2012
5. Filling up forms and collection of trade test Fee with fine @Rs.100/-per trainee. 20.01.2012
6. Final date of receipt of application forms including the Forms filled up with late fines to be submitted at State Council through Special Messengers. 21.01.2012
